8.7. - AQUABIKE INTERNATIONAL MANAGEMENT COMMITTEE COMMISSION

Commission consists 8 members and one president (7.2.1.1.1) and "Every UIM contracted promoter will automatically have a seat with the right of one vote in the Commission on matters that concern his promoted class and which do not affect the governing/institutional aspects which are and will be the exclusive competence of the governing body."
